ACT Nomination Overview

Introduction

The Department of Home Affairs allows us to nominate applicants for two types of skilled migration visas in the ACT:

- [Skilled Work Regional Visa \(subclass 491\) \(provisional\)](#)
- [Skilled Nominated Visa \(subclass 190\)](#)

Carefully check the details on the [Department of Home Affairs website](#) for each visa type to make sure that you:

- choose the right visa for your situation.
- meet all of Department of Home Affairs' eligibility criteria for that visa.

SkillSelect EOI

Before you start the ACT nomination process, you must submit a valid [expression of interest \(EOI\) via SkillSelect](#). This is an online application process administered by the Department of Home Affairs. If you do not meet the Home Affairs criteria you cannot apply for ACT nomination.

If you are invited to apply for ACT nomination, you must continue to meet the Department of Home Affairs criteria until your application for ACT nomination is assessed. The ACT cannot confirm a nomination on SkillSelect if you do not meet the Department of Home Affairs criteria for your selected visa subclass.

ACT Migration manages the nomination process, but the Department of Home Affairs manages the [visa application process](#). Please note, we cannot answer any questions about applying for your visa or the current visa processing time.

Expressing interest in ACT Nomination

You must be invited to apply for ACT nomination. Read the eligibility criteria carefully for your chosen nomination pathway. Once you are satisfied that you meet the eligibility criteria, you can express your interest in ACT nomination by completing the [Canberra Matrix](#). We use the Matrix to fairly manage the nomination process and select applicants who will best contribute to the Canberra region.

The Matrix is a merit-based assessment tool where you can score points for your (potential) economic and / or social contribution to Canberra e.g., length of ACT residence, occupation, business activity, employment, English, study, investment and close family ties.

We will rank your Matrix based on your residency, occupation, and the number of points you have claimed. Those who rank high enough will receive an invitation to apply for ACT nomination.

Please note: *the demand for ACT nomination may exceed the annual allocation of nomination places. There is no guarantee that your Matrix score will be ranked, even if you meet the eligibility criteria.*

One Nomination Place per Person Policy

We only offer one nomination place per person. If you are successfully nominated for a 491 or 190 visa, you cannot apply for another ACT nomination place. The ACT Government reserves the right to make an exception at its discretion and in exceptional circumstances. You can only reapply for ACT nomination if you meet the eligibility criteria and if you are applying for **the same visa subclass**.

We have a fixed number of nomination places available each year to help support the ACT economy. Once nominated, we do not get that nomination place back. It would therefore be unfair if applicants were given two or more nomination places.

Reapplying for ACT nomination

The ACT Government reserves the right to allow applicants to reapply for ACT nomination at its discretion and in exceptional circumstances. You must be able to demonstrate that you have a **genuine reason** for reapplying for ACT Nomination. You can only reapply for ACT nomination if you meet the eligibility criteria and if you are applying for **the same visa subclass**.

To request the ability to reapply for ACT nomination, please submit a new Canberra Matrix in the same visa subclass and email migration@act.gov.au with the Canberra Matrix reference number requesting the duplicate bar to be lifted. In your email, you must explain the exceptional circumstances that meant you could not apply for your ACT nominated visa and include supporting documentation where relevant. Your request must address the criteria identified below.

Your case will only be considered if we are satisfied you have taken all reasonable steps to avoid the necessity for renomination. Bear in mind, it is always the applicant's responsibility to ensure the ACT Nomination application, SkillSelect EOI, and visa application are accurate.

We will remove the duplicate application flag from your Matrix and place it in the queue for ranking if we are satisfied that your request meets the following criteria:

- You were unable to apply for your visa due to exceptional circumstances.
- You have taken all possible steps to avoid the necessity for renomination and to ensure your application will be successful if you were to be renominated.
- The impact on other applicants is minimal.
- Renomination would be of significant benefit to the Territory.

The outcome of your request may solely be based on the demand for nomination places in your nominated occupation or visa subclass as well as the overall remaining allocation in that financial year.

If your application for renomination is rejected based on the demand for nomination places and the impact on other applicants, you may reapply for ACT nomination six months after that decision was made.

ACT Nomination Pathways

You must carefully read the eligibility criteria for the ACT nomination pathway that you are interested in. If you do not meet the eligibility criteria, you cannot submit a Canberra Matrix.

ACT Nominated Migration Program Occupation List

This pathway seeks to select highly skilled migrants with nominated occupations that are in demand in the Territory or where there is anticipated demand for that occupation. Canberra Matrix submissions with a nominated occupation in a critical sector may be prioritised. Critical sectors include the care, education, construction, renewables and advanced technology sectors.

To follow this pathway, you must have an occupation on the [ACT Nominated Migration Program Occupation list](#) and you and any dependents cannot be in Australia (*except children enrolled in an ACT school*).

You cannot apply under this pathway if you are living in Australia. If you live in the ACT, please refer to the guidelines for ACT residents published on [our website](#).

Doctorate Streamlined Nomination

The Doctorate Streamlined nomination pathway aims to retain highly skilled migrants who have completed a PhD at an ACT university by streamlining the ACT nomination process to make it easier for applicants with a PhD from an ACT university to obtain ACT nomination. This includes a fee free application process.

To apply through this pathway, you must be an Interstate / overseas applicant: you were awarded a Doctoral degree from an ACT university within the last two years.

Your nominated occupation does not need to be on the ACT Nominated Migration Program Occupation list, you do not need to meet other ACT nomination eligibility criteria (including additional English requirements) or claim points on the Canberra matrix. You cannot apply under this pathway if you did not study at an ACT university.

The following documents must be included in your application and be valid at date of Canberra Matrix submission:

- A current skill assessment in the nominated occupation;
- Your Doctorate completion letter or Doctorate award from an ACT university; and

- Your SkillSelect Expression of Interest (EOI) record of response which shows the personal, education, English and employment details submitted.

Significant Economic Benefit

You may be invited to apply for ACT nomination if we think your employment is of significant economic benefit to the Territory, and you do not meet the current eligibility criteria. You cannot request or apply for this pathway. The invitation can **ONLY** be initiated by the ACT government.

How to Apply for ACT Nomination

Once you have confirmed you are eligible to apply for your visa, follow the process below to apply for ACT nomination.

Step 1 – Submit a Valid Expression of Interest on Skills Select

Decide on the visa pathway that is right for you, check that you meet all of the Department of Home Affairs' eligibility criteria for that visa, and submit a valid expression of interest (EOI) via SkillSelect.

Step 2 - Check your eligibility for ACT nomination

Read the ACT nomination guidelines carefully and make sure that you are eligible to apply for ACT 491 nomination or ACT 190 nomination.

Step 3 – Submit a Canberra Matrix

Once you are satisfied that you are eligible to apply for ACT nomination, you can complete a Canberra Matrix using the ACT Migration Application Portal. You can use this portal to lodge and manage Canberra Matrix submissions and ACT Nomination applications as well as pay relevant application fees.

By lodging a Canberra Matrix submission, you are confirming you are eligible to apply for your visa, you meet ACT nomination eligibility criteria, and you can demonstrate your Canberra Matrix claims. For more information about the documents you would need to supply if you are invited to apply for ACT nomination to demonstrate your claims, check the key document checklist.

You can check your Canberra Matrix score using the Matrix calculator. Once you have checked your score, complete the Canberra Matrix, select only the points you can validly claim and demonstrate in line with these guidelines and the key document checklist.

Pay the service fee

After submitting your Canberra Matrix, you must pay the Canberra Matrix submission fee. You can pay this fee in the ACT Migration Application Portal within 7 days of submission. If payment is not received in this time, your Canberra Matrix submission will lapse automatically. Canberra Matrix submissions will not be ranked until the payment has been received and confirmed.

Update or withdraw your Canberra Matrix

In case your circumstances change or your claimed points increase / decrease, you can update or withdraw your Canberra Matrix at any time before an invitation is issued. There is no charge to update or withdraw a Canberra Matrix.

If you update your Canberra Matrix:

- the updated submission will replace the previous submission;

- the updated submission will be treated as a new Canberra Matrix for ranking purposes; and,
- you must be able to demonstrate that you are eligible to apply for your visa, meet ACT nomination eligibility criteria, and demonstrate your Canberra Matrix claims on the date of the update, even if the points claim is unaffected.

Step 4: Wait for your Canberra Matrix to be ranked and invited

ACT Migration conducts regular invitation rounds throughout the year with a tentative invitation schedule being published at the start of the migration program year on the [ACT Migration website](#).

Canberra Matrix Selection

Canberra and Overseas residents may be ranked separately, as the Canberra Matrix differs depending on your residency status. For Overseas Applicants, only Canberra Matrix submissions with a nominated occupation on the latest ACT Nominated Migration Program Occupation List will be selected and, if ranked, invited to apply for ACT nomination. The highest ranked Canberra Matrix submission in each occupation will be invited.

The cut off for selection will depend on demand, the available places, and the number of invitations being issued. Canberra Matrix submissions for the Skilled Work Regional (subclass 491) visa will be selected first. Minimum cut-off scores will be published on the ACT Migration website after every invitation round.

If there are too many Canberra Matrix submissions with the same score, then selection may be based on the date and time you submitted the Canberra Matrix. If you have updated your Canberra Matrix submission, the submission date is the date last updated.

Important note: you will not be invited if you have previously received ACT nomination or if you have an active application in the system. This means that your 190 Matrix (if any) will not be ranked and selected if you have an active invitation issued for a 491 Matrix.

Canberra Matrix validity

Canberra Matrix submissions will automatically lapse after six months if an invitation is not issued and no updates are made to the Canberra Matrix in that time. Canberra Matrix validity will be extended by six months if you update your Canberra Matrix with a maximum validity of 12 months from original Canberra Matrix submission.

Requests for ranking information

Invitations are not guaranteed. We will not respond to requests for information on ranking or the likelihood of receiving an invitation. Canberra Matrix submissions will not be prioritised nor will invitations be issued based on personal circumstances. This includes, but is not limited to, visa expiry dates or a change in circumstances including critical birthdays.

Step 5: If invited, apply for ACT nomination

If your Canberra Matrix is selected, you will receive an invitation to apply for ACT nomination. An ACT nomination application will automatically be created in your [ACT Migration Application Portal](#) account.

Accepting the invitation

Before you accept the invitation, check that the information in your SkillSelect EOI and the SkillSelect EOI responses are correct as they cannot be updated if ACT nomination is approved and confirmed on SkillSelect.

If you are at all concerned about the accuracy of your SkillSelect EOI, seek advice from a registered migration agent before you submit your application for ACT Nomination. If you only find out after submitting your application (but before you receive ACT nomination) that there is an error on your SkillSelect EOI, contact us **immediately** or consider withdrawing your application in the [ACT Migration Application Portal](#).

Please note, by accepting the invitation for ACT nomination and submitting your application, you are confirming:

- all the responses on your SkillSelect EOI are correct
- you can demonstrate that you meet ACT nomination and Department of Home Affairs visa criteria now and at date of Canberra Matrix submission, and
- you can demonstrate all your Canberra Matrix claims.

The ACT only offers one nomination place per person so make sure you can successfully apply for your visa.

Submit the application and pay the service fee

The application for ACT nomination is active for 14 days. You must submit the application and pay the [service fee](#) within this time. If your application is not submitted within the 14-day period, the invitation will lapse. Once the service fee payment is confirmed, your application will be queued for processing.

Step 6: Assessing your application

We will process all applications in the order they are submitted. When we assess your application, we will look at your:

1. [SkillSelect EOI](#): to check that you are eligible to apply for the visa, your claims, and make sure you have sufficient points on SkillSelect to apply for the visa.
2. [Supporting documents](#): Your supporting documentation must evidence your eligibility to apply for ACT nomination, any Canberra Matrix points you have claimed, and that you continue to meet Department of Home Affairs criteria. A decision may solely be based on the documents in the application. We are not required to look at

any documents other than the ones that you attached to the application. It is the responsibility of the applicant, or their agent, to ensure all documents are uploaded, accurate, and up to date at the date the application is submitted.

If your application is approved, we will confirm ACT nomination on your SkillSelect EOI, which triggers the invitation from the Department of Home Affairs to apply for the visa.

ACT nomination does not guarantee that the visa will be granted.

Requests for expedited assessment

Applications are generally finalised within three weeks. However, you may request expedited assessment of your ACT nomination application if within ten working days:

- your visa will expire
- your English test, skills assessment, or passport will expire
- you will lose points for age and this will bring your total points below the minimum required for the visa.

What happens if your application is refused?

If your application is refused, we will tell you why you were unsuccessful. You can ask us to reconsider this decision if an error was made by the case officer. Any request for reconsideration must be in writing, explaining why you consider the decision is wrong. The review may solely be based on the original documents attached to the application.

You can submit a new Canberra Matrix if you are satisfied that your documents now support your eligibility and Matrix claims.

Step 7: Apply for your visa

You have 60 days to apply for the ACT nominated visa. The offer of ACT nomination expires after 60 days.

If you can't / decide not to apply for the visa, the nomination place is lost – we don't get it back from the Department of Home Affairs. Therefore, we **only offer one nomination place per person**. It is not fair to other applicants if you are given two or more nomination places.

Disclaimer

The ACT Critical Skills List, nomination guidelines and eligibility criteria are subject to change without notice at any time.

The Australian Migration Program does not guarantee a migration outcome for any temporary resident / international student in Australia, neither does the ACT guarantee a nomination pathway even if applicants meet the eligibility criteria. The demand for ACT nomination exceeds the Department of Home Affairs allocation of nomination places. Submitting a Canberra Matrix is therefore no guarantee of an invitation. A Canberra Matrix score may not rank highly enough to be selected and invited to apply for ACT nomination.

The ACT Government and its employees are not liable for any inaccuracies or omissions in the information provided to the applicant in the context of their application for ACT nomination.

The ACT Government is not responsible for finding employment, accommodation or providing financial incentive or assistance to ACT nominated skilled visa holders or other migrants.

If your application for an ACT nominated visa is refused by the Department of Home Affairs, the ACT Government will not, under any circumstances, appeal to the Administrative Review Tribunal on your behalf.

ACT Nomination Eligibility Criteria

To apply for ACT nomination, you must meet certain criteria at the date you submit or update the Canberra Matrix. The criteria that apply to you depend on the visa subclass and your residency status. Below are the ACT nomination eligibility criteria for Overseas residents per visa subclass.

Skilled Regional Work Visa (subclass 491)

If you want to apply for ACT nomination for a Skilled Regional Work (Provisional) visa (subclass 491) as an *Overseas resident*, you must meet the *following criteria* at the date you submit or update the Canberra Matrix:

- **Department of Home Affairs Criteria:** you meet the relevant Department of Home Affairs Criteria and can apply for your visa. You must meet this criterion when you submit your Canberra Matrix and continue to do so until you receive ACT nomination. This includes having a valid English test and Skills assessment.
 - Your English test and Skills assessment must be valid at date of Canberra Matrix submission and at date of ACT nomination.
- **Pathway:** you must meet one of the following:
 - Nominated Occupation: your nominated occupation is on the latest ACT Nominated Migration Program Occupation List;
 - Doctorate Streamlined: you completed a professional or research doctoral degree at an ACT university in the last two years, you live overseas / interstate and are eligible to apply for your visa – your nominated occupation does not have to be on the ACT Nominated Migration Program Occupation List and you do not need to meet other ACT nomination eligibility criteria listed below (including additional English requirements).
- **Relevant overseas work experience:** you have at least one year full time, post graduate work experience in your nominated occupation in the last five years. The work experience must be assessed as relevant by the assessing body in your points tested skills assessment (*if a points advice service is provided by the assessing body*).
 - Your skills and experience in the nominated occupation are relevant to the ACT economy.
 - If required, you hold the relevant Australian registration or licence for your nominated occupation.
- **English:** You meet the Department of Home Affairs requirement for 'competent' English unless a higher level is required by your assessing authority.

- **ACT employability:** you have researched the ACT labour market and you are satisfied that you are employable in Canberra and that your background is relevant to the ACT economy. *Please note, you may not be eligible to apply for positions within the Australian Government due to citizenship / security clearance requirements.*
 - You must attach an employment statement explaining the research undertaken and confirming that you are employable in Canberra. The statement should include recent job vacancies you are eligible for.
- **Commitment to Canberra:** you have researched Canberra and you are committed to living in the ACT.
 - You must attach a commitment statement to the application, explaining in your own words why you want to live in Canberra.
 - You must sign a declaration committing to living and working in Canberra for at least two years from the date of arrival in Australia.
- **Residency:** you and any migrating dependents (*except children enrolled at school in the ACT*):
 - are living overseas.
 - have not lived in Australia for the last 12 months.
 - do not hold a current Australian visa (or bridging visa) with the exception of an Australian visitor visa.
- **Settlement funds:** you have access to sufficient money to fund your migration and settlement in Canberra.
- If you have a **Spouse / Partner** and you wish to claim Canberra Matrix points in a spouse or partner category:
 - You must have proof of the relationship: either a marriage certificate or civil partnership/union certificate. For ACT nomination purposes, we do not accept a de facto relationship without a relationship certificate unless you cannot legally obtain a relationship certificate in your country of residence.
 - When claiming Matrix points in the spouse / partner employment category, they must meet the Department of Home Affairs requirement for 'competent' English; or hold an Australian passport.

Your supporting documentation must evidence your eligibility to apply for ACT nomination and any Matrix score claimed. Please refer to the key document checklist for more information on what documents you need to include.

A service fee is payable when submitting your application. You can go to ACT Migration Application Fees for more information about applicable fees.

Skilled Nominated Visa (subclass 190)

If you want to apply for ACT nomination for a Skilled Nominated (Permanent) visa (subclass 190) as an *Overseas resident*, you must meet the *following criteria* at the date you submit or update the Canberra Matrix:

- **Department of Home Affairs Criteria:** you meet the relevant Department of Home Affairs Criteria and can apply for your visa. You must meet this criterion when you submit your Canberra Matrix and continue to do so until you receive ACT nomination. This includes having a valid English test and Skills assessment.
 - Your English test and Skills assessment must be valid at date of Canberra Matrix submission and at date of ACT nomination.
- **Pathway:** you must meet one of the following:
 - Nominated Occupation: your nominated occupation is on the latest ACT Nominated Migration Program Occupation List;
 - Doctorate Streamlined: you completed a professional or research doctoral degree at an ACT university in the last two years, you live overseas / interstate and are eligible to apply for your visa – your nominated occupation does not have to be on the ACT Nominated Migration Program Occupation List and you do not need to meet other ACT nomination eligibility criteria listed below (including additional English requirements).
- **Relevant overseas work experience:** you have at least three years full time, post graduate work experience in your nominated occupation in the last five years. The work experience must be assessed as relevant by the assessing body in your points tested skills assessment (*if the points advice service is provided by the assessing body*).
 - Your skills and experience in the nominated occupation are relevant to the ACT economy.
 - If required, you hold the relevant Australian registration or licence for your nominated occupation.
- **ACT employability:** you have researched the ACT labour market and you are satisfied that you are employable in Canberra and that your background is relevant to the ACT economy. *Please note, you may not be eligible to apply for positions within the Australian Government due to citizenship / security clearance requirements.*
 - You must attach an employment statement explaining the research undertaken and confirming that you are employable in Canberra. The statement should include recent job vacancies you are eligible for.

- **English:** You meet the Department of Home Affairs requirement for 'Proficient' or 'Superior' English unless your nominated occupation:
 - Is Chef 351311; or,
 - Has an ANZSCO skill level of 3 to 5.
- **Residency:** You and any migrating dependents (*except children enrolled at school in the ACT*):
 - are living overseas.
 - have not lived in Australia for the last year.
 - do not hold a current Australian visa (or bridging visa), except an Australian visitor visa.
- **Commitment to Canberra:** you have researched Canberra and you are committed to living in the ACT:
 - You must attach a commitment statement to the application, explaining why you want to live in Canberra. The statement must be written in your own words.
 - You must sign a declaration committing to living and working in Canberra for at least two years from the date of permanent arrival in Australia.
- **Settlement funds:** you have access to sufficient money to fund your migration and settlement in Canberra.
- If you have a **Spouse / Partner** and you wish to claim Canberra Matrix points in a spouse or partner category:
 - You must have proof of the relationship: either a marriage certificate or civil partnership/union certificate. For ACT nomination purposes, we do not accept a de facto relationship without a relationship certificate unless you cannot legally obtain a relationship certificate in your country of residence.
 - When claiming Matrix points in the spouse / partner employment category, they must meet the Department of Home Affairs requirement for 'competent' English; or hold an Australian passport.

Your supporting documentation must evidence your eligibility to apply for ACT nomination and any Matrix score claimed. Please refer to the key document checklist for more information on what documents you need to include.

A service fee is payable when submitting your application. You can go to ACT Migration Application Fees for more information about applicable fees.

Canberra Matrix

Introduction

You can express an interest in applying for ACT nomination by completing a score-based 'Canberra Matrix' where points can be claimed against specific criteria including skilled employment, English proficiency, formal qualifications, length of ACT residence / study, investment activity and close family ties, etc.

The Canberra Matrix is weighted to ensure that applicants who will make/have made a positive economic contribution to the Territory and/or have demonstrated a genuine commitment to the ACT are more likely to invited to apply for ACT nomination.

Read the eligibility criteria for ACT nomination carefully. Once you are satisfied that you meet all the criteria, you can submit the Canberra Matrix. We will rank your Canberra Matrix based on points you have claimed. Those who rank high enough in their occupation will receive an invitation to apply for ACT nomination. The cut-off will depend on demand, the available places, and the number of invitations being issued

Remember, unless otherwise indicated in the eligibility criteria or Canberra Matrix, your supporting documents must prove that your claims for Matrix points are true and accurate at the date you submitted - or last updated - the Canberra Matrix. While you wait for an invitation, you must continue to meet Department of Home Affairs visa criteria.

If you are invited to apply for ACT nomination and your supporting documents do not demonstrate that you meet the eligibility criteria for ACT nomination or substantiate all your Canberra Matrix claims, the application will be refused.

There is no guarantee that your Matrix score will be ranked, even if you meet the eligibility criteria.

ACT Migration Application Portal

You can submit a Canberra Matrix for a Skilled Work Regional (subclass 491) or Skilled Nominated (subclass 190) visa using the ACT Nomination Application Portal.

The ACT Nomination Application Portal allows you to securely:

- Lodge a new Canberra Matrix submission;
- Edit or withdraw your Canberra Matrix;
- If invited, submit an ACT nomination application;
- Track your application progress; and,
- View current and previous Canberra Matrix submissions or applications.

To access the ACT Nomination Application Portal, every user will need to create an account.

Create your account

You can create an account as a general applicant, migration agent, or employer (for Regional Certifying Body support applications only) by going to the [ACT Migration Application Portal](#) and signing up (for a step-by-step guide, please visit [our website](#)).

- **Step 1:** Enter your email address
- **Step 2:** Verify your email address by requesting a verification code. Once you receive the code, enter it in the required field to complete the verification process.
- **Step 3:** Create a password
- **Step 4:** Enter your account details
- **Step 5:** Select your role (general applicant or migration agent)
- **Step 6:** Download the Microsoft Authenticator app and set up multi-factor authentication (MFA) to secure your account.

You can then access your account by going to the [ACT Migration Application Portal](#) and logging in using your email address, password, and the authentication code from your authenticator app. The first time you log in, you will be asked to fill out your profile page.

Migration agents acting on behalf of a client must register an agent's account. The Canberra Matrix can be accessed from your agent portal. When submitting an application on behalf of your client, you must always include their personal email address in the application.

Manage your Canberra Matrix Submissions

The [ACT Migration Application Portal](#) allows you to submit, view previous, edit, and pay for Canberra Matrix submissions.

Submitting a New Canberra Matrix

- **Step 1:** Go to 'Canberra Matrix Submissions' and select "New Canberra Matrix Submission".
- **Step 2:** Enter or edit your personal details, select a nominated occupation, nomination pathway, and your residency status.
- **Step 3:** Click next and select one option for each Canberra Matrix category.
- **Step 4:** Click next, confirm the information is correct, and pay the [Canberra Matrix fee](#) within seven days.

Once you submit the Canberra Matrix, you will receive an email with a summary of the Matrix score claimed. You can also view your Canberra Matrix at any time in the portal.

Multiple Canberra Matrix Submissions

You can only submit two Canberra Matrix submissions per nomination pathway for a maximum of four occupations. Invitations for the Skilled Work Regional (subclass 491) visa are issued first. You will not receive an invitation for ACT nomination of a Skilled Nominated (subclass 190) if you have already received an invitation to apply for ACT nomination of a 491 visa.

Managing Existing Canberra Matrix Submissions

When you go to 'Canberra Matrix Submissions' you will find an overview of the Canberra Matrix submissions you have lodged. Here you can pay for, update, view, or withdraw your Canberra Matrix submissions by selecting the downward pointing arrow to the right and then selecting the action you want to take.

There is no charge to update or withdraw a Canberra Matrix and you can do so until the Canberra Matrix submission is invited or lapsed.

Once you update the Canberra Matrix, you will receive an email with a summary of the Matrix score claimed. You can also view your Canberra Matrix at any time in the portal.

To view previous Canberra Matrix submissions, you may have to adjust the filters, which you can find above the Canberra Matrix submission overview.

Manage your ACT Nomination Application

If your Canberra Matrix is selected, you will receive an email inviting you to apply for ACT nomination. Once the invitation is issued, an ACT nomination application will be automatically generated in the ACT Nomination Application Portal.

Submit a new nomination application

Once invited, you must complete and submit your application through the portal and pay the service fee within 14 days of receiving the invitation by following these steps:

- **Step 1:** Go to 'ACT Nomination Applications'
- **Step 2:** Go to the application in question, click on the blue downward arrow to the right, and select edit.
- **Step 3:** Fill out all the requested information and upload your supporting documents.
- **Step 4:** Confirm the information is correct and pay the application fee.

Once the service fee payment is confirmed, your application will be queued for processing. If your application is not submitted within the 14-day period, the invitation will lapse and expire.

Managing Existing and Previous Nomination Applications

You can find your applications by logging in to your account in the ACT Migration Application Portal and navigating to 'ACT Nomination Applications' where you can view past applications and edit, withdraw, or pay for current applications.

After you submit your application, you can track your application progress in the ACT Nomination application portal by adjusting the filters above the application overview from in progress to awaiting decision or all applications. If you identify any error on your application or are concerned about the accuracy of your SkillSelect EOI, you can withdraw your application in the portal at any time before your application is finalised.

You will not be able to request any update or withdrawal of your application after you have been nominated.

Canberra Matrix Scoring

To express an interest in ACT nomination, the Canberra Matrix must be completed for each nomination pathway you are interested in (ACT 190 or 491 nomination). You can only select one option in the dropdown menu for each category. Before you can claim points, you must meet the category criteria at the date you submit or update the Canberra Matrix. If you are invited to apply for ACT nomination, your supporting documents must evidence any Matrix points claimed.

Key documents – Overseas applicant

The following documents must be attached to prove your eligibility to apply for ACT nomination and the Canberra Matrix score claimed. A decision may solely be based on the documents in the application. We are not required to look at any documents other than the ones that you attached to the application. It is the responsibility of the applicant, or their agent, to ensure all documents are uploaded, accurate, and up to date at the date the application is submitted.

- ☐ **Home Affairs SkillSelect EOI summary:** showing personal, education, English and employment details submitted.
- ☐ **Home Affairs SkillSelect points advice.**
- ☐ **Current / valid skills assessment in the nominated occupation with points advice showing dates of the relevant work experience assessed:** all pages of the assessment must be attached and the dates on the skills assessment must substantiate your eligibility and Canberra Matrix claim. If your current / valid skills assessment is issued after you submit your Canberra Matrix, you must also attach the skills assessment in your application that was valid at date of Canberra Matrix submission.
- ☐ **Passport bio-data page.**
- ☐ **Curriculum Vitae (CV) or Resume:** which clearly states personal details, educational qualifications, and work experience.
- ☐ **Current Visa Entitlement Verification Online (VEVO):**
 - For you and your partner/spouse (*if applicable*).
- ☐ **Declaration of ACT nomination obligations:** a signed and witnessed declaration that you acknowledge and accept ACT nomination obligations to live and work in Canberra for at least two years from visa grant.
- ☐ **English:**
 - A valid English language test result that meets the Department of Home Affairs requirement for the level of English ability you have claimed (in the Canberra Matrix and / or ACT eligibility criteria). ☐ **Previous ACT residence** *(if applicable)*

- International Movement Record from the Department of Home Affairs.
- The claimed arrival date in Canberra must be proven by a bank statement/s showing commencement of ACT transaction activity. Note: visits to Canberra do not meet the residence criteria. Your bank statements must reflect that you were living and settled in Canberra.
- Proof of having stayed at least seven consecutive nights in Canberra, including date of arrival and departure, accommodation receipts or evidence of close family ties, and flight itinerary. A statement about staying with friends / family is not considered proof.

☐ **Relevant Overseas Work experience**

- Current skills assessment with points advice and dates of the relevant work experience assessed *(if this service is provided by the assessing body)*. The skills assessment must substantiate your eligibility or Canberra Matrix claim of overseas work experience.
- You can claim relevant overseas work experience in addition to the years specified in your points tested skills assessment, **provided** that the employment has already been positively assessed (e.g. you continued to be employed in the same position that has already been assessed and your skills assessment remains valid). The duration of any relevant employment not included on the skills assessment must be evidenced with an employment reference letter, salary statements, and an employment contract (including duties and responsibilities).
- The SkillSelect EOI must record the relevant work experience.

☐ **ACT job offer** *(if applicable)*

- ACT employment contract
- Evidence that the ACT employer has tested the labour market within the last three months and is unable to find an Australian Citizen or permanent resident to fill the position.

☐ **Employer statutory declaration** *(if applicable)*: your ACT employer **MUST** declare:

- your position title, position description, duties, salary, and proposed commencement date.
- that you will be employed in a genuine position in Canberra in accordance with Australian legislation.
- the position is relevant to the operations of the business.
- the minimum period of employment is for at least two years.

☐ **ACT employability**

- Attach an employment statement explaining the research you have undertaken of the ACT labour market and confirm that you are satisfied that your skillset and

experience are relevant to the ACT economy and that you are employable in Canberra in your nominated occupation. *Please note: you may not be eligible to apply for positions within the Australian Government due to citizenship / security clearance requirements.*



Spouse/partner (if applicable):

- Passport bio-data page.
- Proof of relationship: marriage certificate, civil partnership/union registration, or VEVO secondary applicant status for yourself or spouse/partner.
 - If you cannot legally obtain a relationship certificate in your country of residence, you can still claim points provided you request a waiver for this requirement. You must demonstrate that you cannot legally obtain a relationship document, that you are in a de facto relationship, and your partner must be listed as a secondary applicant on your visa.



Spouse/partner employment (if applicable):

- Evidence of six months full time employment e.g., payslips and employer statement of service.
- Proof they meet the Department of Home Affairs requirement for 'competent' English; or hold an Australian passport. If you have claimed points for your partner's English level, they must have an English test at the claimed level.
- Valid skills assessment relevant to their current occupation (if applicable).
- Academic transcript to evidence the claimed period of full-time study (if applicable).



Tertiary qualification

- Academic Transcript: record of your enrolment history, including results received, courses attempted, and awards conferred.
- Letter of course completion from tertiary institution.



Period of completed ACT study (if applicable)

- Academic Transcript from ACT institution: record of your enrolment history, including results received, courses attempted, and awards conferred.
- Letter of course completion from ACT tertiary institution.



Close family members living in Canberra

- Proof of the close familial relationship with the Canberra resident:
 - Spouse/partner: marriage certificate, civil partnership/union certificate; or
 - Birth certificates to prove the familial relationship between you and the ACT family member.
- From your Canberra relative:
 - Proof of two years ACT residence: bank statements, rates notice, utilities bill or PAYG summary; and

- Proof of Australian citizenship or residency.

Please note: statutory declarations will NOT be accepted as proof of relationship.

- ☐ **Commitment statement:** In no more than two pages, explain in your own words why you want to live in Canberra for at least two years from date of arrival.
 - Signed declaration committing to living and working in Canberra for at least two years from the date of permanent arrival in Australia.
- ☐ **Financial capacity:**
 - Signed financial declaration declaring you own sufficient assets to fund your migration to Australia and settlement in Canberra.
- ☐ **ACT assets:**
 - Residential or commercial property: Certificate of Title and/or rates notice; purchase settlement statement; proof of minimum \$250,000 cash investment; letter of mortgage approval (if applicable).
 - Evidence of majority business ownership, ABN, ASIC Current and Historical Australian Registered Body Extract, Business Activity Statements (BAS) for the last six months.
