## FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by Infrastructure Canberra (iCBR), on 25 September 2025.

In your information access request, you sought access to:

*“Please provide all communication between iCBR and the offices of the Chief Minister and/or the Deputy Chief Minister relating to upgrades to the Erindale Active Leisure Centre since 19/10/2024.”*

### Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

### Timeframes

In accordance with section 40 of the Act, iCBR is required to provide a decision on your access application within 30 days. Therefore, a decision is due by **10 November 2025**.

### Decision on access

Thorough searches of iCBR records have failed to identify any documentation in relation to your request. The searches were conducted using the information you provided.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by iCBR.

### Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request as no documents are being released to you.
