#### 1. Overview

SYNERGY is the Nursing and Midwifery Research Centre supported by ACT Health based at the Canberra Hospital. SYNERGY is an acknowledgement by ACT Health and the University of Canberra (UC) of the need to support a research culture across the health system in the ACT. This culture encourages engagement and collaboration, achieves regular outputs in key focus areas, enhances collaboration with key stakeholders, establishes international links with other centres, and develops a successful cohort of higher degree research students in nursing and midwifery.

Five areas of research focus have been identified as current strengths based on research outcomes including publications in refereed journals, research income and higher degree student enrolments and capacity:

- mental health nursing and psychosocial wellbeing
- midwifery and women centred care
- cancer and oncology
- health workforce, education, and quality outcomes
- gerontological nursing and care of the older person.

This report showcases the extensive work that SYNERGY undertakes in supporting nurses and midwives to develop, implement, and evaluate innovations that deliver person-centred care and improve outcomes for consumers, carers, and the health system in the ACT and elsewhere. It demonstrates SYNERGY's leadership in exploring, understanding, and reshaping health care services, and in ensuring the next generation of nurses and midwives have the skills and insight to continue to generate and use evidence to enhance health throughout the community.

#### **Mr Anthony Dombkins**

ACT Chief Nursing and Midwifery Officer – ACT Health Directorate

Anthony Dombkins is the ACT Chief Nursing and Midwifery Officer, a position he has held since January 2020. Previously the Director of Nursing and Midwifery, Northern Sydney Local Health District, Anthony graduated as a registered nurse in 1987 and holds postgraduate clinical certificates in renal and transplantation nursing and intensive care nursing, as well as a Masters, Health Management. Anthony has held a variety of senior health management positions within the

public and private health sectors across NSW. In June 2014, Anthony was appointed an Adjunct Professor, Nursing with the University of Sydney and the Australian Catholic University. Anthony was also a member of the Clinical Excellence Commission Advisory Board and a Board Director for Stewart House.



#### **Professor Michelle Lincoln**

Executive Dean, Faculty of Health – University of Canberra

Professor Michelle Lincoln (B App Sci, PhD, FSPA, PFHEA) is the Executive Dean of the Faculty of Health, University of Canberra. Professor Lincoln was formerly the Deputy Dean, Associate Dean Learning and Teaching and the Head of Discipline of Speech Pathology in the Faculty of Health Sciences, University of Sydney. She was the inaugural chair of the Asia Pacific Education Collaboration in Speech Pathology. Professor Lincoln's research in education is focused on competency-based assessment in clinical settings, clinical education models, ethical development and

interprofessional learning. Professor Lincoln writes on and researches allied health service delivery and workforce, particularly in rural, remote and Indigenous communities. Professor Lincoln's research has been funded by the National Health and Medical Research Council, the Australian Research Council, and the NSW Government. She has published more than 150 peer-reviewed journal papers as well as books and book chapters. Professor Lincoln has won university and national teaching awards for her educational expertise in Speech Pathology. She is a Fellow of Speech Pathology Australia and a Principal Fellow of the Higher Education Academy.

# **Professor Deborah Davis**Clinical Chair and Professor of Midwifery

A joint appointment by the ACT Government, ACT Health Directorate and the University of Canberra, Faculty of Health.

Professor Deborah Davis (BN, MNS, PhD) is a midwife with an extensive career in clinical practice (midwifery-led, continuity models of care), midwifery education and research. She is also active in the profession, having served for four years on the Board of Directors for the Australian

College of Midwives, two of which were in the role of Vice President. Professor Davis is committed to improving maternity services for childbearing women and people, through midwifery education, research, and service development. She supports research students to focus on clinical research that is important to our maternity services in the ACT and has worked with clinicians in the ACT to improve clinical outcomes in areas such as stillbirth prevention and protection of the perineum in childbirth. She has contributed chapters to pre-eminent midwifery textbooks, co-developed the world's first midwifery Massive Open Online Course (MOOC) on evidence-based practice, published extensively in scholarly journals, and plays a leadership role in service development in the ACT. Professor Davis' research interests focus on promoting wellness in childbearing women and people using salutogenic approaches, particularly in relation to birth environment and weight gain in pregnancy.



#### **Professor Catherine Paterson**

Clinical Chair and Professor of Cancer Care and Nursing

A joint appointment by the ACT Government, ACT Health Directorate and the University of Canberra, Faculty of Health.

Professor Catherine Paterson (PhD, BA, MSc, PGCert. LTA, FHEA) conducts research in all areas of cancer care. She has expertise in conducting systematic reviews, ecological momentary assessment methodology, mixed methods, complex interventions, and clinical trials. Professor Paterson has over 17 years' experience working in health services research, has published widely, and supervises Higher Degree by Research (HDR) students.

Professor Paterson provides senior leadership for the Prehabilitation Activity Cancer Exercise Survivorship (PACES) research group at the University of Canberra, ACT Health, and Canberra Health Services. The PACES clinical academic research group has multidisciplinary healthcare representation from nursing, medicine, and allied health, including consumer representation and Aboriginal and Torres Strait Islander representation.

We will develop clinically meaningful outcomes and what matters most to people living with and beyond cancer, while providing cost-effective solutions to reduce economic burden in primary and secondary care. Our synergistic clinical and academic research partnerships mean we lead and develop research that has translation pathway for impact directly back into practice. Our mission is to improve the lives of the estimated 130,000 Australians diagnosed with cancer each year. – PACES research group



#### **Professor Michael Roche**

Clinical Chair and Professor of Mental Health Nursing

A joint appointment by the ACT Government, ACT Health Directorate and the University of Canberra, Faculty of Health.

Dr Michael Roche (RN, PhD, FACN) has a wide-ranging research portfolio in mental health and health services using quantitative, multi, and mixed methods, including studies that have integrated longitudinal and cross-sectional data to provide new insights. His recent work has focused on professional pathways for mental health nurses, nurse resilience and retention, mental health safety

culture, and workplace violence. He also has wide experience in clinical environments, education, information technology, and management positions in the public mental health system. He has attracted substantial research funding and has many publications, book chapters, conference presentations, and reports. He presently supervises research students exploring aspects of mental health nursing, person-centred care, resilience, workplace violence, and restrictive practices. Michael emphasises collaboration and engagement in his work, and mentors new researchers across clinical and academic settings, including leading a team of new researchers across University of Canberra and ACT Health currently engaged in exploring Safewards implementation needs. Michael liaises with mental health and drug and alcohol services and non-government organisations across the ACT. He works closely with the Mental Health Justice Health Alcohol and Drugs Service (MHJHADS) to support nurses in their transition to mental health settings and in developing quality improvement and research activities.



#### **Professor Kasia Bail**

Clinical Chair and Professor of Gerontological Nursing

A joint appointment by the ACT Government, ACT Health Directorate and the University of Canberra, Faculty of Health.

Dr Kasia Bail is known for her work examining health services, older people and nursing. Dr Bail's work is positioned at the intersection between 'ageing well' and 'care delivery' by exploring the underlying social causation and impact of clinical prioritisation and decision making experienced by older adults, particularly for people experiencing cognitive impairment. With funding from

industry and government she has examined older person care in relation to digital health systems, nurse sensitive outcomes, health information systems, aged care nurse practitioners, prognosis communication, costs, and dementia care in residential aged care as well as community and hospital settings. Dr Bail maintains casual hospital shifts and enjoys sharing scholarly inquiry with nursing students, industry, and professional groups to address structures and processes that enable quality person-centered care. Dr Bail enjoys co-designing research with the communities that the research serves and works with undergraduate and Higher Degree by Research students and clinicians to identify challenges and opportunities to translate evidence into practice related to person-focussed care for the older person. Key working teams for policy, practice and research impact include the Rehabilitation Aged and Community Services of ACT Health, ACT and South Eastern Regional Team for Service Delivery Division, Ageing and Aged Care Group, Aged Care Workforce Branch, Market and Workforce Division, Australian Government Department of Health and Aged Care, Aged Care Nursing Roundtable, Capital Health Network, Ageing Research Group of University of Canberra, Aged Dementia Health Education and Research (ADHERE) Centre of University of Wollongong, and many individual residential aged care organisations.

The SYNERGY Nursing and Midwifery Research Centre is supported by the Office of the Chief Nursing and Midwifery Officer, ACT Health administration team.

# 2. Research Internship Programme



The Research Internship Programme began in 2021 and aims to provide nurses and midwives with an opportunity to develop their knowledge and skills in research.

Supported by the ACT Office of the Chief Nursing and Midwifery Officer, interns are seconded from their employing division within ACT Health, Canberra Health Services or former Calvary Public Hospital Bruce (now North Canberra Hospital (NCH)), on a 0.5FTE basis for a period of 12 months to the centre. During the 12 month placement, interns complete the

Graduate Certificate in Health Research with the University of Canberra, completing a research project that is relevant to their clinical service area. Interns are provided with mentorship and support from the SYNERGY clinical chairs in midwifery and nursing.

This programme was suspended in 2022 due to the demands of the clinical setting and will recommence toward the end of 2023. Previous interns have emphasised the value of this programme both to the organisation and individually.

# 3. SYNERGY Innovation Scholarship

SYNERGY Innovation Scholarships (previously Practice Development Scholarships) support nurses and midwives to undertake research, practice, or process improvement projects within their work areas with the ongoing support and guidance from their direct supervisor, the director of nursing and midwifery, and an academic mentor.

The aim of the scholarship is to increase the evidence base of nursing and midwifery practice, support practice or process improvements in the clinical area and improve outcomes for health service users.

Scholarship recipients present their findings in the SYNERGY nursing and midwifery grand round with health service nursing and midwifery leaders and contribute to service-level evaluation and development related to their topics.

This program was suspended during the COVID-19 pandemic due to the demands of the clinical setting. It is due to recommence toward the end of 2023.

# 4. Honours scholarships

The Bachelor of Midwifery (Hons) and Bachelor of Nursing (Hons) programs are offered to high performing graduates of the Bachelor of Midwifery or Bachelor of Nursing degree. The program involves a supervised research thesis which is undertaken over 1 year full time or 2 years part time. Most students undertake the program on a part time basis alongside employment in their graduate year or beyond.

Their research project is negotiated with senior health service staff members to ensure it is relevant and useful to the service and also within the scope of the honours program.

This program attracts high performing graduates to Canberra Health Services, and the former Calvary Public Hospital Bruce, now North Canberra Hospital. Graduates completing the program have high level skills and knowledge in project management, evidence-based practice, research methods and communicating research findings. Graduates from the honours program are well equipped not only to undertake further research, but to lead quality improvement and other projects, critically appraise evidence for practice, and develop clinical policies.

# 5. Nursing and midwifery grand rounds: Research and practice development forums

The nursing and midwifery grand rounds are held monthly in the SYNERGY area at The Canberra Hospital in the Clinical School. Each forum has 2 presenters who showcase their research on a wide variety of topics relevant to nurses and midwives. The forums also provide a solid networking platform with attendees from various departments across hospitals and academics from universities.

The forums are held in a hybrid format (virtual and face-to-face), ensuring flexibility in attendance for all nurses and midwives across the ACT. Participation has been strong with up to 10 attendees per forum and 80 in total.

# 6. Research development series

The research development series features a range of virtual forums for all levels of healthcare practitioners to explore innovation in practice, and to champion and lead service design. These forums are held online monthly to support healthcare practitioners to develop skills, knowledge and research skills and capability. Each forum includes a presentation to cultivate critical thinking to lead cutting edge research in healthcare.

Participation has been strong with 228 participants in total, with a high of 78 participants in the March 2023 session and an average of 28.5 overall.

# 7. SYNERGY impact

One of SYNERGY's main roles is to facilitate the translation of evidence into practice, to positively impact patient, nurse, midwife, and health system outcomes. A key component of this work is the engagement and support of clinical nurses and midwives, and junior academic researchers.

Developing, undertaking, and disseminating research with clinicians develops an understanding of rigor with impact on quality initiatives and translation of research into clinical practice. Over time this develops a community of clinicians with the capacity to access, translate, and apply research to their work. This leads to both immediate and clear policy or practice change (for example, see internship and scholarship vignettes above), and translation that develops over a longer period.

The latter is particularly true when practice change is significant. Engagement and interactions raise consciousness and are a key component of the theory to practice translation work. Nonetheless, SYNERGY's work has had immediate impact on the Canberra health community and more broadly.

The following examples highlight this impact:

#### **World Delirium Day Point Prevalence Survey**

Professor Bail was able to lead Canberra Health Services (CHS) in participating in the global World Delirium Day Point Prevalence Survey. The highest rates of cognitive impairment were found on: 7B, 5B, 11A, 11B (all more than 20% of patients), 9B, 5A, 4B, 7A, Short Stay MH (more than 10%), 9A, AMHU, 4A, Cotter, 14B, 10A, Majura, Namadji (3-10% of patients). This was illuminating for clinicians and managers and supported the implementation of a 3-pronged strategy for cognitive impairment education to be instigated.

Despite having hundreds of people with delirium and dementia admissions every year, and hundreds of online education modules, CHS did not yet have any education modules on delirium or dementia or how to assess or treat.

With support from the SYNERGY nursing and midwifery research centre, the OCNMO and the Aged and Rehab Stream and Delirium Committee, led by Professor Bail, the Dementia Training Australia modules were implemented into CHS online education. A cognitive impairment educator commenced, who provides in services and introductions to the modules, as well as more in-depth cognitive behaviour support across the hospital. The online modules had 90 enrolments within 2 weeks of being made available, demonstrating a high need and high uptake.

The point prevalence survey provided information that wards were able to consider and respond to and provided the circular approach of providing empirical outcomes to clinicians regarding their patients to support practice change. There are ongoing plannings to involve North Canberra Hospital in the developments and a high level of responsiveness to this need for professional development in relation to people with cognitive impairment in hospital.

A diagnosis of delirium is a predictor of unnecessary functional decline, falls, longer hospital stays, increased morbidity and mortality, permanent cognitive damage, and likelihood of admission to an aged care facility. Up to 50% of older adults are at risk of delirium when hospitalised and older adults who acquire delirium are 3-times more likely to die within 24 hours of admission than older adults without delirium.

People with dementia are more likely to experience delirium, and more likely to have their delirium overlooked. With an estimated healthcare services cost of \$8.8 billion, this is a key area for nursing practice to improve in the assessment, management, and safety practices, for individual patients and their families' experiences, as well as health service function and efficiency.

### Older person nursing roundtable

A second example of impact includes the older person nursing roundtable, with 55 attendees at the event hosted by Love Decency Kindness (LDK) Seniors' Living in May. This annual event has been requested to be biannual, due to the success of the networking and project development.

Two other key areas of work following the event are the formation of a working group to improve digital health record (DHR) discharge information to residential care, with a focus on effective discharge, and a registered nurse exchange program between acute and residential settings with an emphasis on reducing unnecessary hospital admissions. These examples highlight the necessary transboundary intersections between acute and residential care to impact on quality of experience and length of stay that are key areas of concern for health services.

#### Point of care ultrasound in third trimester pregnancy

An example of impact in midwifery includes the point of care ultrasound in the third trimester of pregnancy. Responding to a need identified by maternity services in the ACT, the University of Canberra in collaboration with clinical services, developed and successfully delivered a point of care ultrasound course for 18 midwives.

Led by clinical chair, Professor Deborah Davis, the course was collaboratively developed by clinicians and sonographers in the clinical setting, and midwifery and medical imaging academics at the University of Canberra. Focusing on ultrasound assessment in the third trimester of pregnancy, the course aims to facilitate more timely assessment of pregnant women and people who present with decreased fetal movements or where presentation of the fetus is difficult to determine by palpation in early labour for example, which in turn will improve care.

Prior to the introduction of the course, obstetricians and obstetric registrars were the only healthcare professionals able to perform the assessment. Maternity services reported long waiting times for women and people requiring point of care ultrasound due to increased demand and a lack of staff members educated to perform this assessment. Demand for the point of care ultrasound rose significantly as elements of the Safer Baby Bundle, which is being supported by SYNERGY, were implemented into maternity services in the ACT.

The course should lead to significant improvements as midwives can now perform this assessment without having to wait for busy obstetricians or registrars to attend the woman and people. The development of the course is a good example of how clinical care can be improved when experts from the clinical setting and academia are engaged and work in collaboration.

# 8. Community engagement

SYNERGY undertakes a range of approaches to communication and dissemination of research. This is important not only in disseminating new research evidence but as noted above, is also a fundamental component of research translation with the nursing and health communities and the public. An example of community engagement includes:

Professor Deborah Davis leading the Brighter beginnings: Maternal and child health research
group in a co-design project funded by a Healthy Canberra Grant. In collaboration with Health
Care Consumer's Association and Multi-Cultural Hub, ACT, this project aims to increase physical
activity levels of women of childbearing age from Culturally and Linguistically Diverse (CALD)
communities.
