FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by Chief Ministers Treasury and Economic Development Department (CMTEDD) on 20 July 2022, in which you agreed to the following scope:

“When the contract was finalised for the Gungahlin Aquatic Centre 50m pool – what was the indicative date of the completion of the 50m pool?”

CMTEDD referred your request to Major Projects Canberra (MPC) as we hold information relevant to your request. On 4 August 2022, we advised you MPC was accepting a full transfer of your request.

Authority

I am an Information Officer appointed by the Chief Projects Officer under section 18 of the Act to deal with access application made under Part 5 of the Act.

Decision on access

Searches were completed for relevant documents and one (1) document was identified that falls within the scope of your request. This document is MPC’s Gungahlin Leisure Centre Repair and Refurbishment Project Weekly Report for the week ending 14 April 2021. This was the week the contract for this project was finalised. You will note the indicative date for the completion of the project at that stage was **20 December 2021**.

I have decided to partially release the document relevant to your request.

Statement of Reasons

In making my decision on disclosing government information, I must identify all relevant factors in schedule 2 of the FOI Act and determine, on balance, where the public interest lies. In reaching my access decision, I have taken the following into account:

Factors favouring disclosure in the public interest (Schedule 2, Section 2.1)

- Section 2.1(a)(i) - promote open discussion of public affairs and enhance the government’s accountability; and
- Section 2.1(a) (ii) contribute to positive and informed debate on important issues or matters of public interest.

Factors favouring non-disclosure

Information that is outside the scope of your request.

Charges

I have decided to waive any charges in relation to this Freedom of Information application.

Online Publishing – Disclosure Log

Under section 28 of the Act, MPC maintains an official online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the MPC disclosure log three (3) days after the date of the decision. Ombudsman Review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in the MPC disclosure log, or a longer period allowed by the Ombudsman.
