I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by Infrastructure Canberra (iCBR), formerly Major Projects Canberra on 3 October 2024.

In your information access request, you sought access to:

“Copies of all emails and their attachments, from any ACT Government email address associated with Major Projects Canberra or ACT Property Group staff which were sent to, or received from, email addresses with a suffix of '@ljhookerstrata.com.au' (in any of the To, From, CC or BCC fields) between 01 February 2024 and 25 September 2024”.

Authority

I am an Information Officer appointed by the Director General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Decision on access

Searches were completed for relevant information and a total of 252 e-mail items within 146 parent folders were submitted to the Freedom of Information (FOI) team for assessment. As discussed through e-mail correspondence with the FOI team, this large volume of documentation requires manual assessment. The manual assessment identified duplicate e-mail threads, and other non-substantive content.

For completeness the FOI team requested a second search to ensure that no correspondence had been missed. The subsequent search returned an additional 61 email items which underwent the same manual assessment.

Of the 459 items (and folders), 99 pages were identified as falling within the scope of your request.

I have included the following as attachments to this Release Pack:

- Attachment A: Schedule of relevant documents,
- Attachment B: Decision letter, and
- Attachment C – Attachment E: Information for release

The schedule of relevant documents provides a brief description of each item that falls within the scope of your request and the decision of release for each of item.



My decision in relation to the documents relevant to your request summarised as follows:

- Partial access to 97 pages, and
- Items withheld due to information already publicly available (two pages)

My decision is detailed further in the following Statement of Reasons.

Statement of Reasons

In making my decision on disclosing government information, I must identify all relevant factors in Schedule 2 of the Act and determine, on balance, where the public interest lies.

In reaching my access decision, I have taken the following into account:

Factors favouring disclosure in the public interest (Schedule 2, Section 2.1)

- Section 2.1(a)(i) – promote open discussion of public affairs and enhance the governments accountability;
- Section 2.1(a)(iii) – inform the community of the government’s operations, including the policies, guidelines and codes of conduct followed by the government in its dealings with members of the community;
- Section 2.1(a)(v) – allow or assist inquiry into possible deficiencies in the conduct or administration of an agency or public official; and
- Section 2.1(a)(vii) – advance the fair treatment of individuals and other entities in accordance with the law in their dealings with the government.

The release of this information will ensure that a balance is struck between confirming that the government may function effectively and efficiently and provide access to information to increase public participation in, and scrutiny of, government activities.

Additionally, iCBR is committed to upholding the highest standards of safety, integrity and accountability in everything that we do, and I am satisfied that these are relevant considerations favouring disclosure in this case, and in the interests of enhancing open discussion, I afford them significant weight.

Factors favouring non-disclosure in the public interest (Schedule 2, Section 2.2)

- Section 2.2(a)(ii) – prejudice the protection of an individual’s right to privacy or any other right under the *Human Rights Act 2004*;

This document contains personal contact information for non-government employees, and I place significant weight on the right to privacy of individuals and their right to have personal contact and identifiable information protected. Any identifiable property information such as building address has also been redacted to further protect the privacy of individuals.

- Section 1.14 – Law enforcement or public safety information;

This category of contrary to public interest information protects against potential threats to public safety being caused by the release of information. Correspondence relevant to you application contains details of buildings in the Australian Capital Territory which are at various stages of remediation of combustible cladding.

It is reasonably expected to affect public safety to identify any buildings which may still contain combustible cladding, and there is an undue risk it would present through endangerment of physical safety as a result of disclosure.

I have decided on balance that due to the risks associated with disclosing the identity of any building that may still contain combustible cladding it is not in the Public Interest to release this information.

- Section 2.2(a)(xi) – prejudice trade secrets, business affairs or research of an agency or person. I have also considered the impact of disclosing information which relates to business affairs. In the case of *Re Mangan and The Treasury* [2005] AATA 898 the term 'business affairs' was interpreted as meaning 'the totality of the money-making affairs of an organisation or undertaking as distinct from its private or internal affairs'.

Schedule 2 section 2.2(a)(xi) allows for government information to be withheld from release if disclosure of the information could reasonably be expected to prejudice the trade secrets, business affairs or research of an agency or person.

Correspondence relevant to your application contains information that I consider private business matters of third parties that is not in the Public Interest to release.

Charges

I have decided to waive any charges in relation to this Freedom of Information application.

Online Publishing – Disclosure Log

Under section 28 of the Act, iCBR maintains an official online record of access applications called a Disclosure Log. Your original access application, my decision and documents released to you in response to your access application will be published on the iCBR Disclosure Log within three to ten working days after the date of the decision.

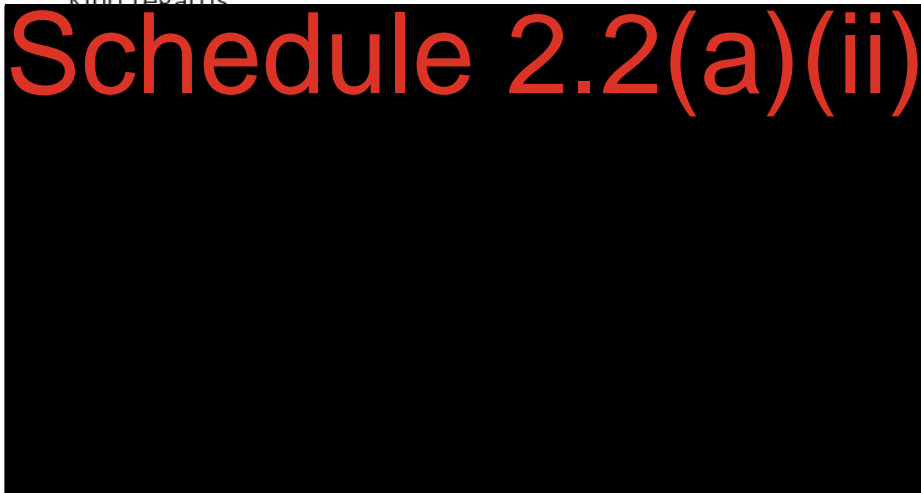

Why are we writing to you?

WorkSafe ACT previously arranged for a licensed asbestos assessor to inspect the mulch at your property. A result of this inspection found mulch located at your property to be contaminated with small amounts of bonded asbestos which needs to be removed.

A copy of the Asbestos Assessment Report was provided to you previously.

We are writing to advise there has been a delay in the commencement of these works, from the previously advised commencement date.

Update on remediation progress

ACT Property Group is undertaking a process to establish a new contract to finalise remediation works on the remaining identified properties. Unfortunately this is taking longer than anticipated and we will provide you with another update with further information in late September 2024 with an indication of the schedule of when the remediation works will be undertaken.

ACT Government is committed to securing and remediating the asbestos affected mulch and replace it with clean mulch at your property as quickly as possible at no cost to you.

What is the health risk of asbestos when it's in my mulch?

Statutory notices issued by WorkSafe prohibit disturbance to the land for sites which have cottage mulch containing asbestos.

It is acknowledged, and widely supported by evidence, that when asbestos materials are contained in a bonded form that is maintained in a good condition and left alone, they present no health risk. However, asbestos becomes a potentially dangerous substance when asbestos fibres are released into the air and the fibres are inhaled.

There is a low risk to the community if the mulch is left as is. However, the risk increases if contaminated mulch is disturbed. Asbestos fibres can pose a risk to health if airborne, as inhalation is the main way that asbestos enters the body.

If you are concerned about your level of exposure to asbestos, you may wish to speak with your medical practitioner to discuss your concerns.

You can also register your details on the National Asbestos Exposure Register, under Asbestos Risks and Exposure at: www.asbestossafety.gov.au/

What do you need to do?

It is very important that the mulch at your home is not disturbed, handled, or disposed of. Please keep children, residents, and pets away from the mulch. Please do not do any gardening or weeding in the areas where this contaminated mulch has been identified.

Please follow any advice that WorkSafe ACT and the licensed asbestos assessor have given you.

Where can I get more information?

We encourage you to contact **Ashley Martins at ACT Government on Schedule 2.2(a)(ii)** if you have any concerns or questions about the contaminated mulch removal.

We apologise for any inconvenience you may have experienced, and we thank you for your cooperation and assistance in relation to this matter.

My apologies for the delay in getting back to you, we spoke late last week about you wanting to send some comms out regarding the asbestos contaminated mulch for the [Schedule 2.2\(a\)\(ii\)](#) [Schedule 2](#). I said that I would send through some information that you could potentially include with the comms outlining the hazards of asbestos, and how the clean-up will be handled. I have included this below; hopefully it covers everything. If you wanted to clarify any of the points please let me know.

You also asked about the possibility of doing weeding or similar garden maintenance of plants in the affected area. The advice I have received about this is it that you would need to follow the requirements outlined in the prohibition notice from WorkSafe ACT. Do you have a copy of this? I haven't seen the actual prohibition notice myself, but my assumption is that it would likely prevent ground maintenance until the mulch has been remediated. If you continue to get complaints regarding the weeding, please let me know and I can see whether WorkSafe ACT can advise of any interim measures they'd be happy with.

Also to give you a bit of an update on how things are progressing, we're currently carrying out some due diligence before seeking final approval to proceed with the work. I am hoping to have a confirmed schedule next week, and will then contact you to confirm that the proposed dates are suitable.

HAZARDS OF ASBESTOS AND ADVICE ON SITE MANAGEMENT

- A licensed asbestos assessor has assessed the site and confirmed that the risk of exposure to airborne asbestos fibres from bonded asbestos is low.
- The majority of asbestos detected on site is bonded asbestos, where the asbestos is included with another solid material. Example of this include asbestos cement, fibro sheets and vinyl floor tiles.

- There was also a small amount of friable asbestos detected on site. Friable asbestos is more dangerous because it can break up into fine particles that are easily inhaled.
- The licensed asbestos assessor, via WorkSafe ACT, has provided advice on suitable safety measures to be taken until the asbestos contaminated mulch can be cleaned up and removed from site. These measures have been deemed appropriate for both the bonded and friable asbestos.
- It is however important that the contaminated mulch on site is not disturbed, handled, or disposed of until the asbestos contaminated mulch has been removed from the site, and the site has been certified clear of asbestos. Please do not undertake any gardening or weeding or landscaping in and around this contaminated mulch.
- You should also make sure your children and anyone else visiting your property - including pets - do not disturb, handle, or dispose of this contaminated mulch.
- The ACT Government will be carrying out a program to clean-up and remove the contaminated mulch, and replace it with new mulch.
- As part of the clean-up process, a licensed asbestos removalist will remove the contaminated mulch from site following all required procedures. They will ensure that all potentially contaminated mulch has been removed from site.
- As part of the clean-up, air monitoring will be carried out on site to detect any asbestos fibres. If non-background asbestos fibres are detected, further clean-up works will be carried out to ensure all of the contaminated mulch has been removed from site.
- The air monitoring will identify any potential migration of asbestos fibres to nearby plants etc, which will then be included in the clean-up process.
- Once the clean-up has been completed, a certificate will be issued by a licensed asbestos assessor certifying that the impacted areas are free of asbestos.

Good afternoon [Schedule 2](#)

Thank you for getting back to me. We attended site on Friday and did a walk around to determine the scope of works. We're currently in the planning stage with the asbestos removalist to determine the best way to do the remediation, and when we can carry it out.

Based on the size of the site, we are thinking that we'll likely need to break up the remediation into stages to minimize impact on individual properties. The plan would still be to tackle the entire site in one go, but may be that we look at fully remediating each area within the site before moving on to the next area. We'll continue to discuss the best option internally and let you know once we have a solid plan in place.

In terms of time frames, there will be a program of remediation work across multiple sites. There is [Schedule 2.2\(a\)\(ii\)](#) that we will be managing; I expect that we will do these two complexes together, either at the start or the end of the remediation program. Again, we're still discussing this internally and I'll let you know once we've got a better idea of how we will manage this.

One thing I did want to confirm with you is the exact locations for the mulch. I've done up a quick map highlighting the various mulch locations. I've made a couple of assumptions here:

- All areas highlighted in red are from the same contaminated supply of mulch and need to be cleaned up and replaced.
- All areas highlighted in green do not need to be cleaned up and replaced. [Schedule 2.2\(a\)\(ii\)](#)

[Schedule 2.2\(a\)\(ii\)](#) Some of these areas have mulch, but it appears to be of a different sort; I am assuming this has either been done separately, or is not an area you

are responsible for.

- The areas highlighted in yellow are the sloped areas leading down to the visitor's carpark/upper pathway. There appears to be a fair amount of established ground cover in these areas, so I wasn't sure if they had been done at the same time as the rest of the mulch; I wanted to confirm that these are also potentially contaminated areas. If you are not sure, we will treat them as such.

Could you please confirm whether the above assumptions are correct, and clarify regarding the sloped area? Hopefully the map makes sense, if not please let me know and I'll sort something else out.

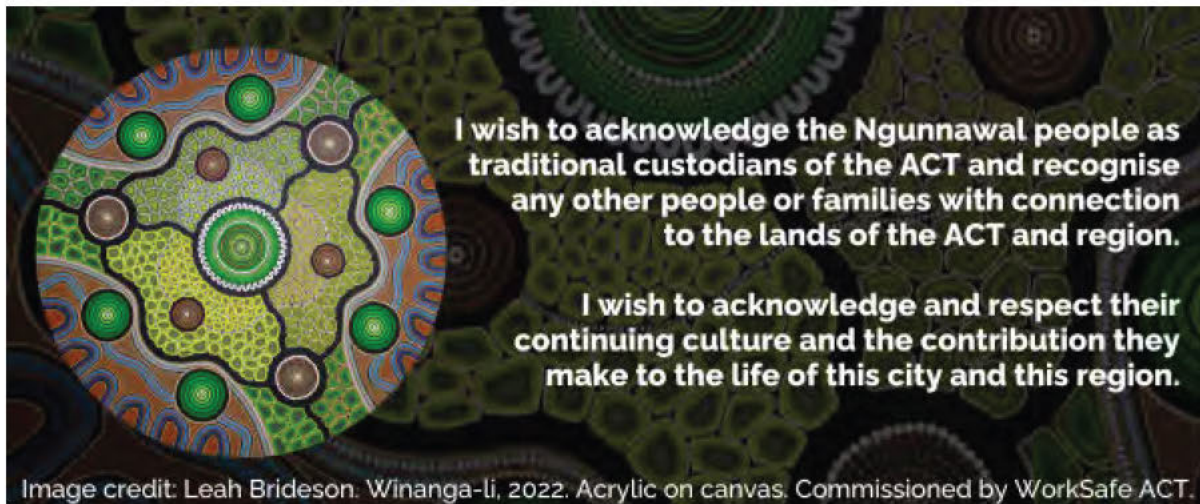

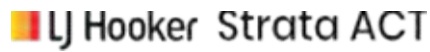

ACT Cladding Program

Checklist for owners corporations who need to undertake an Investigation and Tender Stage and then go to remediation

This check-list covers the application and assessment process and the steps you need to undertake to move eligibility assessment to investigation and tender to remediation and repayment.

Background reading

 - > Concessional Loan Application and Assessment Guidelines
 - > Concessional Loan Remediation Guidelines
 - > Documents under the "Useful tools" link on the "Information for owners" page on the cladding website.



The Investigation and Tender Stage

- Complete an application for eligibility assessment and submit. This form is available at: **Concessional Loan - Major Projects Canberra (act.gov.au)**.
No other information is needed as the Cladding Team should have a copy of the testing and assessment report for your building.
- The Cladding Team will review your application within 1 business day. If further information is needed you will receive an email from the Cladding Team specifying the information or documents needed.
- Once you have provided all the information requested by the Cladding Team, they will review your eligibility and send you an email advising of the outcome of your application within **ten business days** after the day on which they received all the information from you. If you have been found eligible for the concessional loan scheme, the Cladding Team the email sent to you will confirm that you will be assessed by Lannock Strata Finance Pty Ltd (Lannock) for the preliminary loan amount of \$110,000 (GST incl) and include:
 - > a Participation Deed, and
 - > an Authority to Disclose OC Details to Lannock.
- You will need to sign the Authority and return to us. Please send the Authority back to the Cladding Team by email at claddingprogram@act.gov.au. You do not need to sign the Participation Deed at this stage.
- Once we have received your authority to disclose, the Cladding Team will send your contact details to Lannock within one business day.
- Lannock will contact you and invite you to a loan information session.
- After you have attended the loan information session, Lannock will send you an information pack about the loan. The pack will include requests for specific credit assessment documents, you will need to provide the requested documents.
- Upon receipt of all requested documents, Lannock will undertake a credit assessment and advise you of the outcome of your loan application. If successful, Lannock will send you a draft loan agreement.

Meeting of owners corporation and signing of documents

- You will have to hold a meeting with all members of the owners corporation to decide whether to:
 - > execute the participation deed with the ACT Government
 - > execute the loan agreement with Lannock, and
 - > authorise signatories to execute the participation deed and loan contract with Lannock.
- > raise these with Lannock (speak to Ruth Smyth at 1300 295 759 or by email at actcladding@lannock.com.au) and/or
- > obtain legal advice from a solicitor (note – up to \$10,000 for the life of the loan may be spent on administrative costs, including strata managers, legal advice, accounting assistance or software).

Please note you must execute the participation deed before Lannock can finalise the loan agreement.

Please remember that you have six months from the execution of the loan contract with Lannock to finalise the investigation and tender stage.

- If you have any questions regarding the motions or facility agreement, you can:

- If you decide to enter into the participation deed and the loan contract with Lannock, you will need to:
 - > send the Cladding Team a copy of the executed participation deed and the minutes of the meeting in which the owners corporation agreed to execute the participation deed
 - > Post the following original documents to Lannock Strata Finance at Unit 18.01, Level 18, 227 Elizabeth Street Sydney 2000:
 - wet copy executed Loan agreement, and
 - minutes of the Meeting in which the relevant resolutions were passed.

Please note you will start paying interest on all amounts drawn-down in the Investigation and Tender stage.

- Once both agreements have been fully executed, you need to hire a building industry service provider to take off the cladding and investigate the external wall. On most occasions this will be a builder, but it may also be a façade or structural engineer. The building industry service provider will provide you with a report of the work that needs to be done on the external wall.

Please note some work on the external wall is not permitted to be done using concessional loan funds, including:

- > any changes to windows
- > any pre-existing defects not related to combustibility
- > replacement of extensive mould, and
- > replacement of extensive rotting timber.

Please note any works estimated to cost above \$1 million require the involvement of a project manager. If you think that your costs will exceed \$1 million it may be advisable for you to hire a project manager to assist you with the investigation of the external wall and the tender process.

- Once you have undertaken the investigation of the external wall, you will then need to undertake a tender process to attract a builder who is able to undertake the work needed. In your tender documents you need to include a list detailing the works needed to be done regarding the cladding remediation and the external wall (Scope of Works).

- Once you have undertaken the site investigation of the external wall and the tender process you will need to submit to the ACT Government:

- > the investigation report of the external wall
- > the scope of works
- > the winning tender, and
- > the proposed building contract.

You can submit these documents to us by email at Claddingprogram@act.gov.au. Please note the name of the building in the subject line along with the words “Concessional Loan - Investigation and Tender Documents”.

- The ACT Government will then review all the documents to make sure:
 - > the documents are internally consistent
 - > the cladding remediation and works on the external wall only include eligible works
 - > any ineligible works not to do with cladding or allowed works on the external wall have been properly identified (please note that it is our preference that eligible and non-eligible works be in separate building contracts)
 - > that the building contract for the eligible works include a milestone schedule, the last of which is at least 10 per cent of the entire loan contract and is after:
 - the Cladding Team has received a Recycling Outcomes Report
 - the ACT Government has issued a Certificate of Occupancy.

- Once the ACT Government has reviewed your tender documents and proposed building contract and is satisfied that it includes all relevant information and the last payment milestone is appropriate, the Cladding Team will send an email to Lannock advising them of this and giving them approval to undertake a second credit assessment.

The Remediation Stage



- As noted Lannock may undertake a second credit assessment if required. However, regardless of whether this assessment is undertaken they will check that you have a source of funds equating to 10 per cent of the building contract to fund any work that is not permitted under the concessional loan.
- After Lannock have undertaken their processes, they will send you another draft loan agreement, which will include any drawn amounts from the investigation and tender stage.

Meeting of owners corporation and signing of documents

- You will have to hold a meeting with all members of the owners corporation to decide whether to execute the loan agreement with Lannock. After this meeting, please send the original wet copy of your executed loan contract, and the minutes of the meeting to Lannock.

Please remember that you have 24 months from the execution of the loan contract with Lannock to finalise the cladding remediation, any make-good works and any works on the external wall.

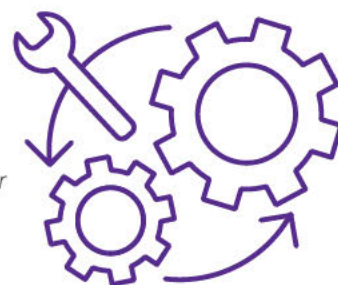
Undertaking the remediation

Choosing your service providers and letting the Cladding Team know

- Remember that you can only contract with architects, builders, certifiers, façade or structural engineers, fire engineers, project managers, and quantity surveyors who are either on the Register of Suppliers or eligible to join the Register.
- Once you have hired your service providers from the above list, you will need to advise the Cladding Team of the name of your service providers. You can do this by emailing the Cladding Team at claddingprogram@act.gov.au.

Payments, the Recycling Report and last milestone payment

- During the remediation you will have to send any receipts to Lannock who will pay directly into the owners corporation nominated bank account so you can pay your building industry service providers involved in the remediation.
- Once the combustible cladding has been removed it must be recycled. Please seek a Recycling Outcomes Report from your builder and send to us before the last milestone payment. Please note the Cladding Team will not approve the payment of the last milestone by Lannock until we have received this report.



Please note if your builder or project manager is unsure what has to be provided as the Recycling Outcomes Report, please ask them to contact the Cladding Team as we will be able to give them advice on what is needed.

- Before the last milestone payment, your building certifier must certify that the remediation works are completed in accordance with the building approval. After this is done, your building certifier will submit to Access Canberra an application for a Certificate of Occupancy. A copy of the Certificate of Occupancy will be sent to you. Please provide a copy of this certificate to:
 - your builder who can then issue their last invoice, and
 - the Cladding Team, who will then approve the payment of the last milestone payment.



Remember:

- > to contact the Cladding Team if you have any concerns about the process or the timeframes
- > that you will have to execute at least **three contracts**:
 - the participation deed
 - the first contract with Lannock (for investigation and tender funds)
 - the second contract with Lannock (for remediation funds).

You may also have to enter into another contract with another financial institution if that is how you are obtaining access to a source of funds for ineligible works (10% of the loan contract).

- > that you will need to send **five sets of documents** to the Cladding Team to progress your loan:
 - the application and any supporting documents
 - an executed Participation Deed
 - the investigation report from the external work, scope of works, winning tender and proposed building contract
 - the Certificate of Occupancy, and
 - the Recycling Outcomes Report.

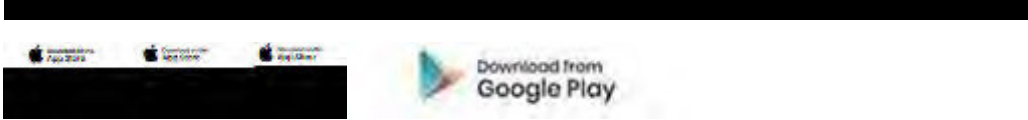

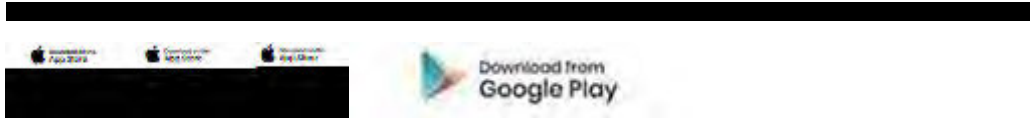
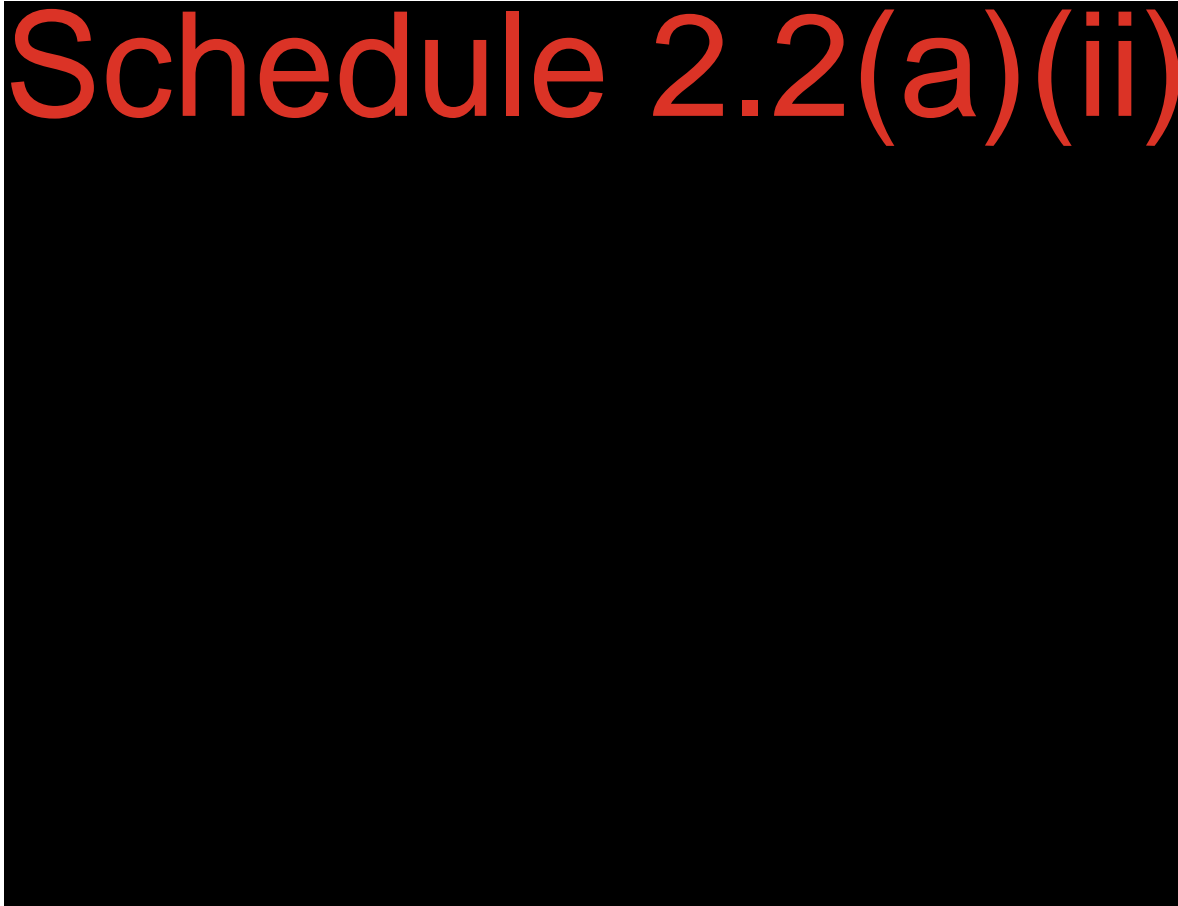

I hope you are well, Sunila forwarded me your email for response.

An investigation report seeks to establish what is behind cladding on a building, this is required to inform the tender process with a view to ensuring that the tender includes a comprehensive scope of works for a remediation.

During the investigation, a selection of panels maybe removed, or sections cut from the panels (which are then patched back up), to enable the investigation to determine any issues that can be (or need to be) rectified whilst the cladding is being replaced. This is the most logical time to undertake this whilst the panels are off the building.

We find that the majority of buildings in the Scheme (and those in other States) have issues that are rectified during remediation, these issues are normally identified during an investigation.

These issues can include water damage, missing sarking, or other items required for certification of the building. Sometimes these are because of the works at the time of construction or can be because of maintenance.

The report would contain details of the issues found during the investigation, and if they are required for certification. The report would then inform the scope of works, the scope of works would be used to tender the project.

I have reviewed the report that [REDACTED] provided [REDACTED], variously this is described as an investigation, though it does not meet what is required under the Scheme for an investigation report, rather this is what the Scheme would consider a 'test report', this is where small samples of the cladding are sent to a lab for testing to determine the combustibility of the cladding. The samples are too small (about the size of 50c coin) to enable anyone to see through the resulting hole to effectively determine what is behind the cladding as required in an investigation report.

There is some information on page 2 of this [document](#) that may assist you and who your choose to undertake the investigation.

The OC can apply for a concessional loan without having a meeting to agree to a meeting. After they put in an application, we assess it and then if the OC is eligible, we will refer them to Lannock Strata Finance who will undertake a financial check. We will also send them a participation deed for their review, the deed is an agreement with the Territory in which the OC agrees to abide by the Territory's guidelines for the Scheme.

Lannock will then contact the OC for a loan information session and ask the OC to send specific documents for a credit assessment. If they are approved by Lannock, the OC will be sent a conditional loan agreement from Lannock. If they wish to pursue the loan, the OC will then have to hold a meeting to pass motions to:

- (a) Enter into the loan agreement with Lannock
- (b) Enter into the Participation Deed with the Territory.

If the above motions are passed, the OC will then need to sign the Participation Deed and return to us along with a copy of the minutes of the meeting (as proof that the motion to enter the deed was agreed to at the meeting). The OC will also need to sign the loan agreement with Lannock and send a hard copy back to Lannock in the post, for their signature.

Lannock has templates for motions it can assist you with, sorry, but we do not provide templates or advice on motions. Just a reminder that, at this stage, concessional loan applications will close on 29 February, 2024. I will let you know if this date gets extended.

You are correct regarding Cladding Remediation, removing combustible cladding that poses moderate to high risk is indeed preferred in order to reduce the risk to low level. The risk mitigation strategies are important to provide the owners corporation with clear and expert guidance on the actions needed to manage the risk level of their building.

Sample testing to obtain risk mitigation is a part of the Comprehensive Testing and Assessment Report for the Rebate Scheme, which was completed on 21 July 2022. As a result, the rebate funds are no longer available, and any testing or assessment after the closing date is not eligible for a rebate.

I hope this provides clarity and the owners corporation would still consider carrying out sample testing to obtain risk mitigation strategies given that Schedule 2.2(a)(ii) <[REDACTED]>.

Sorry, I probably worded my email wrong.

They undertook the visual reporting but did not perform any sample testing as at the time were going to self-fund the removal and reinstatement so there was no benefit in spending more money on core testing. The insurer has provided advice that the property is within acceptable risk for underwriting guidelines (the high risk cladding covers 4% of the entire construction so is incidental exposure).

As the risk is within current guidelines, the owners corporation would like to consider alternate risk mitigation strategies rather than removal and reinstatement. To be able to do this, they need to test two samples.

I understand that from a government point of view full removal would be preferred, but the owners have requested that I confirm if they may be eligible for a rebate on sample testing.

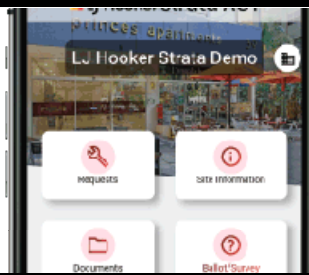

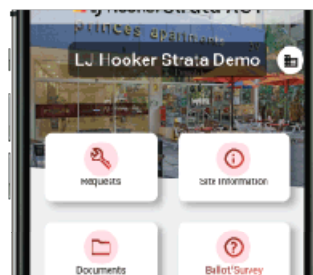

Good afternoon **Schedule 2**

Thank you for getting back to me. We attended site on Friday and did a walk around to determine the scope of works. We're currently in the planning stage with the asbestos removalist to determine the best way to do the remediation, and when we can carry it out.

Based on the size of the site, we are thinking that we'll likely need to break up the remediation into stages to minimize impact on individual properties. The plan would still be to tackle the entire site in one go, but may be that we look at fully remediating each area within the site before moving on to the next area. We'll continue to discuss the best option internally and let you know once we have a solid plan in place.

In terms of time frames, there will be a program of remediation work across multiple sites. There is **Schedule 2.2(a)(ii)** that we will be managing; I expect that we will do these two complexes together, either at the start or the end of the remediation program. Again, we're still discussing this internally and I'll let you know once we've got a better idea of how we will manage this.

One thing I did want to confirm with you is the exact locations for the mulch. I've done up a quick map highlighting the various mulch locations. I've made a couple of assumptions here:

- All areas highlighted in red are from the same contaminated supply of mulch and need to be cleaned up and replaced.
- All areas highlighted in green do not need to be cleaned up and replaced. **Schedule 2.2(a)(ii)**

are responsible for.

- The areas highlighted in yellow are the sloped areas leading down to the visitor's carpark/upper pathway. There appears to be a fair amount of established ground cover in these areas, so I wasn't sure if they had been done at the same time as the rest of the mulch; I wanted to confirm that these are also potentially contaminated areas. If you are not sure, we will treat them as such.

Could you please confirm whether the above assumptions are correct, and clarify regarding the sloped area? Hopefully the map makes sense, if not please let me know and I'll sort something else out.

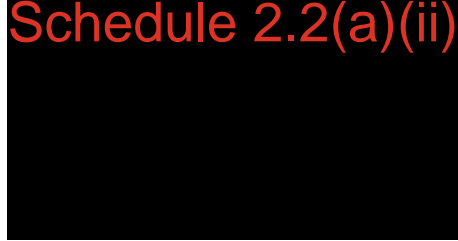
