Canberra households can now register for information about a zero-interest loan up to \$15,000 to invest in rooftop solar panels, household battery storage, zero emission vehicles and efficient electric appliances.

Janet Harris is one of many Canberrans who have made the switch to a more energy efficient way of life.

She replaced her home's gas ducted heating with a reverse cycle system and included solar as part of this switch.

"Our heating costs have halved, and the house is more comfortable to live in," Janet said.

One year into COVID-19

March marks 12 months since Canberra recorded its first active case of COVID-19.

Bronte Morgan was the fourth ACT resident to be diagnosed with the virus.

One year on, the 24-year-old continues to battle fatigue, joint and muscle pain, as well as an unwavering "brain fog".

"It's almost offensive, to be honest, when I hear people complaining about the rules or thinking they're above them and not wanting to comply, because if I had that chance, I would've done what I could to avoid getting it," she said.

COVID-19 vaccine rollout

The first batches of the COVID-19 vaccine are for those at greatest risk of exposure and those most vulnerable to COVID-19.

This includes quarantine and border workers, health care workers in high-risk exposure and transmission areas, and residents and staff of aged care and disability residential care facilities.

The ACT Government is working closely with the Australian Government to make sure everyone in the ACT has access to safe, effective and free COVID-19 vaccines.

Streamlining newborn registrations

The ACT Government is taking part in a pilot program to make it easier for parents to register their newborns.

Through the program, parents will only need to provide their child's details once through a digital system to enrol and register for multiple government services. The first step of the pilot will streamline Medicare enrolment. The full pilot is expected to roll out by mid-2022.

Construction is due to start later this year on a new public transport interchange on Callam Street.

This is the first stage of the new CIT Woden project that will bring state of the art learning facilities and 6500 students to Woden. The new interchange will also incorporate a future light rail stop.

Community consultation last year indicated overwhelming support for an accessible and safer transport interchange, as well as more green space, trees and landscaping.

New Walk-in Health Centre for Coombs

A new Walk-in Health Centre is expected to open in Coombs by 1 July. It will give Molonglo Valley families local access to maternal and child health services.

Work is also underway to expand services at the Weston Creek Walkin Centre, with plans to introduce services to reduce delays at Canberra Hospital imaging department. This will help reduce emergency wait times. Walk-in Centres across the city already provide care for non-life-threatening injuries and illness including lower limb fractures, gastroenteritis, strains or sprains, skin conditions, infections and wounds.

Cleaner, quieter buses for Canberra

The ACT Government's transition to a zeroemission bus fleet by 2040 is well underway. Canberrans can expect to see the first of the 90 electric buses hitting the streets next year. The 34 remaining orange diesel buses left in the fleet are also being phased out and replaced with new buses in the second part of this year. These buses will be wheelchair and pram accessible.
