# Introduction

In the next four years, the ACT Government will commence implementation of *Maternity in Focus: The ACT Public Maternity System Plan 2022-2032*. The actions identified for implementation over this timeframe will deliver essential reform, create the foundation to evolve the public maternity system and deliver the Government's commitment to deliver better care when and where people need it.






Whilst there is a lot of work to be undertaken to deliver on the vision of *Maternity in Focus*, work is already underway to evolve the public maternity system and deliver better care, including:

- » Exploring opportunities to expand homebirth model of care options through Calvary Public Hospital Bruce to increase access and equity.
- » Working with ACT Ambulance Service and ACT Insurance Authority to expand the current geographical boundary for the homebirth service to meet community demand.
- » Working to deliver the new Early Pregnancy Assessment Unit at Centenary Hospital for Women and Children to support women and pregnant people experiencing complications in early pregnancy to receive prompt, compassionate care.
- » Working to implement midwifery and nursing ratios with maternity services in line within the ratios project.

This action plan has been developed through the consolidation of the recommendations from the following documents:

- » Woman-centred care: Strategic directions for Australian maternity services (NMS)<sup>1</sup>
- » Australian National Breastfeeding Strategy 2020 (NBS)<sup>2</sup>
